1. GENERAL CONDITIONS & ORGANISATION

Race & Rally NI, [R&R Logistics – (NI) 16 Longstone Street, Lisburn, BT28 1TP] (the Promotor) will organise the Stellantis Motorsport Rally Cup IRE & UK [Stellantis Rally Cup].

The Rally Cup will be governed in accordance with the regulations of Motorsport Ireland, incorporating provisions of the FIA 2024 International Sporting Code (ISC), The Irish Tarmac Rally Championship, The British Rally Championship and these Championship Regulations, and any bulletins issued by the Promoter.

- 1.1 Unless stated in the regulations issued by the Stellantis Rally Cup, including any commercial agreements, or the promotional, media requirements and compulsory advertising referred to herewith, infringements and appeals will be dealt with under the Motorsport Ireland Judicial procedure.
- **1.2** The Permit for the Stellantis Rally Cup is: P002/24 Issued by Motorsport Ireland.
- **1.3** By entering the Stellantis Rally Cup, you agree to abide by these regulations. Anything that is not expressly authorised by these regulations is forbidden.
- 1.4 Should any dispute arise as to the interpretation of these regulations, the matter shall be referred in the first instance to the Championship Registar. It may subsequently be referred to the Championship Stewards who will operate under Chapter 14 of Motorsport Ireland's General Competition Rules. Decisions of the Championship Stewards shall be subject to Appeal as provided in Chaper 16 of Motorsport Ireland's General Competition Rules.
- **1.5** These regulations come into effect on date of publication.
- 1.6 The Stellantis Rally Cup is open to all drivers and co-drivers who have a minimum valid licence from the following:
 Motorsport UK RS NATIONAL Stage Rally
 Motorsport Ireland Rally National A
 (Please Note: For some events, an International Stage Rally
 Licence may be required as per individual event regulations.)
 Foreign nationals with a valid EU Professional competition licence bearing an EU Flag (ISC 2.6.3a and b) may register for the
 Championship as Drivers or Co-drivers and score points. Drivers and co-drivers outside of the EU must hold the suitable licence to compete in the Cup events as well as approval from their respective ASN. All competitors must have registered in



accordance with Art.10 of these regulations.

- **1.7** Both driver and co-driver must register using the official Stellantis Rally Cup form, declare their class category and pay the appropriate fee.
- 1.8 On rounds 1,3,4 and 7, competitors in the Stellantis Rally Cup will also be bound by the regulations of the Irish Tarmac Rally Championship which must be considered alongside these championship regulations. However, where the Championship regulations contradict, Stellantis Rally Cup Regulations will take precedence. If no specific Regulations exist in the Stellantis Rally Cup Regulations, then the Irish Tarmac Rally Championship Regulations will be utilised.
- 1.9 On rounds 2,5,6 and 8, competitors in the Stellantis Rally Cup will also be bound by the regulations of the British Rally Championship which must be considered alongside these championship regulations. However, where the Championship regulations contradict, Stellantis Rally Cup Regulations will take precedence. If no specific Regulations exist in the Stellantis Rally Cup Championship Regulations, then the British Rally Championship Regulations will be utilised.

4. ELIGIBILE VEHICLES & CONTROL ITEMS

4.1 Stellantis Rally Cup

The Stellantis Rally Cup is open to Peugeot 208 Rally4 or Opel Corsa Rally4 vehicles. Each vehicle must have been originally sold by Peugeot Sport or Opel Motorsport France and have been a factory built example. Any parts not included in the original Rally4 kits or options are prohibited (e.g. quick couplings, additional thermal protection, etc.).

Cars must run in Homologated specification – specific to their Homologation papers. Cars running in right hand drive configuration must be in compliance with Appendix J, Article 252, Article 7.3 of the FIA International Sporting Code regarding the inversion of the driving side.

4.1.1 Stellantis Rally Cup Tyres

All vehicles contesting the Stellantis Rally Cup must use Michelin Motorsport Tyres.

Eligible Asphalt tyres are:

Eligible Gravel tyres are:

Michelin LTX Force T	XL72 Soft	Size: 17/65 - 15
Michelin LTX Force T	XL82 Medium	Size: 17/65 - 15

No other tyre compound is permitted unless informed via a championship bulletin. No other manufacture of tyre is permitted – any breach will result in a forfeit of prize monies for that round and removal of any allocated points on that round.

During all rounds, the use of surface treatment by chemicals, or mechanical action, or any other heating system (heating blankets for example) is prohibited.

4.2 Stellantis Rally Cup Tyre Quantities

On rounds 1,3,4 and 7, competitors in the Stellantis Rally Cup must adhere to any tyre limits set by regulations of the Irish Tarmac Rally Championship.



4.2.1 On rounds 2,5,6 and 8, competitors in the Stellantis Rally Cup must adhere to any tyre limits set by regulations of the British Rally Championship.

5. CUP OUTLINE AND PRIZES

After each rally, according to the final standings, prizes will be awarded as below:

5.1 Stellantis Rally Cup

5.1.1 Prize Money & Awards per rally:

	1 st	€3,000
	2 nd	€1,750
	3 rd	€750
	4 th	€500
	5th	One Michelin Tyre

- **5.1.2** Based on the individual event's final results classification, registered Stellantis Rally Cup contenders will be awarded the prize money as above after each event. For the purposes of clarity, the first registered Stellantis Rally Cup crew home is awarded €3,000, the second place €1,750, third place €750, fourth place €500 and fifth place will receive a Michelin Motorsport Tyre from the list in 4.1.1.
- **5.1.3** From the final event classification at each round of the Cup, a random draw will take place from the list of Cup finishers, outside of the top five crews home. The winner will receive a Michelin Motorsport Tyre from the list in 4.1.1.

5.2 Rally4 Junior Prize

A prize will be awarded to the highest placed Junior Driver in the overall Stellantis Rally Cup standings.

- **5.2.1** To be classified as a Junior Driver, the registered competitor must be less than 26 years old on the 1st January 2024 and declare their eligibility on the championship entry form.
- **5.2.2** To be eligible for the prize, Junior Drivers must have competed on at least six rounds of the Stellantis Rally Cup.



5.2.3 The prize will consist of:

A Drivers Registration to the 2025 FIA Junior European Rally Championship.

FIA Junior European Rally Championship Entry Fee to six rounds of the 2025 FIA Junior European Rally Championship. 12x Tyres per rounds contested.

- **5.2.4** The prize will be distributed after each contested round of the 2025 FIA Junior European Rally Championship is complete.
- **5.2.5** There is no cash alternative and if the prize is unused, it cannot be transferred in any other way.
- **5.2.6** To receive the prize on each round, the winner MUST enter and start the rally as deemed by the event's final classification.
- **5.2.7** To receive the Rally4 Junior Prize, a Peugeot 208 Rally4 or Opel Motorsport Corsa Rally4 MUST be used in the FIA Junior European Rally Championship at which the winner is contesting.
- **5.2.8** The winner must run the branding stipulated by the Stellantis Rally Cup organisers throughout the Junior prize term. The details of the branding will be issued ahead of the first round contested.
- **5.2.9** If less than six rounds of the Stellantis Rally Cup take place, then the Rally4 Junior Prize will not be offered.

6. RALLY 4 CUP POINTS ALLOCATION & REQUIREMENTS

6.1 For the Stellantis Rally Cup only, points will be allocated to Stellantis Rally Cup registered contenders based on each event's general classification, based on the following:

1st	25	6 th	8
2 nd	18	7 th	6
3 rd	15	8 th	4
4 th	12	9 th	2
5th	10	10th	1



6.2 Should any event counting towards the Stellantis Rally Cup not be run in it's entirety, then points will be awarded based on the following:

Less than 50% of the event mileage published in the event regulations – half points.

More than 50% of the event mileage published in the event regulations – full points


- **6.3** From the eight events comprising the Stellantis Rally Cup, the best seven scores will count towards the final classification. If fewer than eight but more than six rounds take place, then six highest scores will count towards the final classification. If less than six rounds take place, then then all rounds will count toward the final classification.
- **6.4** In the event of a tie, the following shall be applied:
- **6.4.1** In the event of a tie at the end of the season, to determine the highest place Stellantis Rally Cup contenders, the winner shall be which competitor from those who are tied, that finished in the highest position on the final round of the season.
- **6.4.2** If this cannot determine the winner, then it shall be decided by which competitor from those who are tied, that gained the highest number of first places, then second places, then third places etc.

7. ADVERTISING AND BRANDING

- 7.1 By participating in the Stellantis Rally Cup, you agree to Race & Rally NI, the promotor, and Motorsport Ireland to use the names, voice, images, video of the crew, the vehicle, performance, and results for promotional and advertising purposes worldwide without restriction.
- **7.2** All vehicles must display ALL the decals as requested by the promotor in the images below. The promotor reserves the right to add to the requirements during the season via a communication.
- **7.2.1** The penalty for non-compliance is the forfeit of any Cup prize money and points for the round that the missing decals are identified on.



7.3 Mandatory decal placement is as follows:





- 7.4 Any advertising on a vehicle, clothing or equipment in the Stellantis Rally Cup cannot be in direct conflict with existing Cup partners or related brands. No automotive manufacturer branding outside of the Stellantis group will be present on any car in the Stellantis Rally Cup without express permission from the promotor. The final decision rests with the promotor. The penalty for non compliance is forfeit of prize money and points for that relevant round.
- **7.5** Every team/crew MUST use the approved awning, frontal banners and flags in any service area. Additional items may be used by the team/crew with your own branding, as long as it does not contravene 7.4.
- **7.6** Driver and co-driver must wear the approved cap dictated by promotor during ceremonial start and finishes and/or awards ceremonies.

8. SCRUTINEERING AND ADMINISTRATIVE CHECKS

- 8.1 Competitors competing in the Stellantis Rally Cup are under the jurisdiction of the Officials and Delegates of the rallies and subsequent Championships in which they compete [Irish Tarmac Rally Championship, British Rally Championship and Junior British Rally Championship]. With the consent of the event, the Stellantis Rally Cup and can reugest scrutineering before, during or after a rally.
- **8.2** The promotor will utilise the Technical Delegate/s of the Irish Tarmac Rally Championship and British Rally Championship on the respective rounds of the Stellantis Rally Cup.
- **8.3** Competitors must provide at least one member of the team for any inspection or disassembly during technical checks. All costs for rebuilding and reassembly will be borne by the competitor.
- **8.4** Seals may be used by the championship Technical Delegate/s and may not be tampered with or removed.
- 8.5 Race & Rally NI, The Irish Tarmac Rally Championship and the British Rally Championship may at any time request data to be downloaded from the vehicle. All data requested must be made available to the Promotor or Championship Technical teams.



9. FINISH PROCEDURE

9.1 To receive any prize monies and/or points, all competitors MUST attend the official event finish ceremony and awards presentation. Any driver or co-driver not attending with the car as required by the promotor, will forfeit all prize money and points for that round.

10. CUP REGISTRATION

- **10.1** All drivers and co-drivers wishing to participate in the Stellantis Rally Cup must register and pay in full using the official Cup entry form.
- **10.2** Entry fees are non-refundable.
- **10.3** All fees must be paid to the promotor before any prize monies or points are awarded, or any equipment and branding is distributed.
- **10.4** The registration fee for driver and co-driver in the Stellantis Rally Cup is:

€1,950

This includes:

Awning

Barriers

Flags

Driver and co-driver registration to the 2024 Probite Junior British Rally Championship (subject to age requirements) or BRC4 class of the 2024 Probite British Rally Championship.

Driver and co-driver registration to the Junior Irish Tarmac Rally Championship (subject to age requirements) or RC4 class of the 2024 Irish Tarmac Rally Championship.

Technical and Parts support on every round

11. PROMOTION AND PUBLICITY

- 11.1 Each competitor and team may be requested to participate in any official media and/or promotional activity. This may include a dedicated media day or promotional events and are not limited to rounds of the Cup. These activities will be at the expense of the competitor.
- **11.2** Each competitor and team may be requested to participate in any official media and/or promotional activity.
- **11.3** Failure to comply with any request to assist with promotional activities may result in loss of prize money or points.



- 11.4 By entering the Cup, competitors, are obliged to assist in the promotion of the Championship and in particular any television coverage, live streaming, radio, news media and attendance at press conferences and functions as required by the promoter/championship or sponsor.
- 11.5 All competitors are obliged to assist the appointed media production company(s) in the filming and/or recording of the Championship events through the granting of interviews when requested and any other reasonable request of the media production company(s).
- **11.6** All competitors must carry an on-board camera. A Cup decal MUST be affixed to the dashboard, in a visible position for the camera at all times. The rights to footage remain with the Promoter.
- 11.7 The image of the Cup must be upheld at all times by entrants, drivers, co-drivers and their teams, at or away from the events. Any entrant, competitor, or person(s) and organisations associated with, bringing any disrepute to the series, its sponsors and officials will be regarded with disfavour by the organisers and the matter will be presented to the Championship Stewards for formal action. Such behaviour will include driving standards of a criminal nature, which are brought to the attention of the Promoter.
